We are very happy to be part of this project as we have been in the past. These are our initial thoughts for the working group and happy to expand further.

- 1. The format of the guide is very good in its current hardcopy form and should not change. The guide needs new photos and some parts need rewording and a new fresh facelift. It should also explain why Animal Welfare Is Paramount to the future of the livestock industry. It should say a bit about POCTA (what ever the national one is) rather than starting with land transport rules. This fit to load guide is mainly for the producer who send problem animals to saleyards and processors.
- 2. The logos on the front cover need updating and possibly more added.
- 3. Inside cover names needs updating and ALMA added.
- 4. Version date needs updating.

- 7. Page 2. 2nd dot point should say on all four legs.
- 8. Page 3. Probably should mention something about prosecution in first paragraph for the loader or owner. Dot point steps, should add curfew for trip.
- 9. Page 5. Is this still current?
- 10. Pages 7, 9, 11. On the bottom of these pages it should have in bold, "if in doubt leave it out" as it is on page 2.
- 11. Page 13. Check the currency of the links, Add the new The Australian Animal Welfare Standards and Guidelines Livestock at Saleyards and Depots. Check accuracy of Dept names and numbers. Add in link to AHA.
- 12. Back cover should have a positive statement about animal welfare.
