

At this point our CEO Andy Madigan and his team have spent countless hours advocating through and with organisations such as NFF, ALEC and government bodies to have the agency body heard and express our support, but also taking into account our concerns with operators working outside best practice and animal welfare regulations and putting markets in jeopardy for all.

CHIEF EXECUTIVE OFFICER'S REPORT

It gives me great pleasure to submit my fifteenth ALPA annual report to members. ALPA is now in its fourteenth year as a national body representing agents across Australia. We truly are, a peak industry body.

I thank the ALPA board members for their dedication during the past 12 months. Our directors are listed in the front of this report. They have assisted in changing attitudes and behaviour amongst other industry stakeholders and members. I also thank members of our Regional Advisory Committees. Their time and valuable contributions assist ALPA achieve positive results within the rural sector.

David Corcoran stood down as President at the AGM in Adelaide 2017 due to the ALPA constitution rule of a four year limit as president. David has led ALPA in the same vain as past presidents and he has put ALPA first and stood up for all agents at all levels. Warren Johnston from Roberts Tasmania was elected as President by the board and with his industry experience and knowledge will make him an ideal leader.

ALPA conducted a survey of members in May to help find out what ALPA needed going forward. The board will assess the outcome of the survey and will make the necessary changes to help set our course into the future.

ALPA lodged nine submissions this past year on behalf of members to state and federal governments and we had two face-to-face meetings with the ACCC on beef markets.

- May 2018 Inquiry into the Primary Industries Levies and Charges Collection Amendment Bill 2018.
- June 2018 NSW Select Committee on Landowner Protection from Unauthorised Filming or Surveillance.

Through these submissions meetings. ALPA continues to make our view and position heard. We continue challenge regulatory bodies throughout Australia to deliver on their responsibilities. This İS becoming increasingly more difficult as state funding for DPI and other agricultural services shrinks with the expectation that agents and others will fill this void.

During the past year ALPA has reached some significant milestones:

With support from Fairfax Media, Wagga Livestock Marketing Centre and the RMA network we were able to live stream the ALPA Young Auctioneers Competition live from Sydney. Also, we live streamed the Victorian and Queensland ALPA Young Auctioneers Competitions right across the country. We had over 22,000 people view the Sydney competition from their computers and phones and Facebook reached over 25,000 people.

- ALPA Facebook page has generated tremendous interest with almost 4,500 followers. Members can now enjoy good news stories as they happen.
- ALPA ran 23 schools and courses across the country delivering information and training to almost 500 members and their staff.
- ALPA members helped raise \$47,077 for The John Logan Foundation.

ALPA has had tremendous support and legal advice throughout the year from our solicitor, Chris Zucker at Zucker Legal in Tamworth. We thank Zucker Legal for their judicious counsel and steadfast support. Our accountant, Michael Hargreaves, continues to have the prosperity and the future of the Association at heart. I thank him for his guidance over the past fourteen years.

Animal welfare is still a hot topic and one that will only get hotter as we have seen from the live export of sheep. Education is paramount in achieving better animal welfare outcomes. People need to understand the difference between animal welfare, animal wellbeing and animal cruelty and education is the only way forward.

ALPA's staff deserves a special thanks and recognition. I thank them for their consistently high performance and the support that is willingly given to members and myself. Liz Summerville in the south is making sure ALPA is represented at all levels. Andrea Lethbridge in the north continues to forge strong links with industry bodies and our members and keeping a focus on current and arising issues nationally for ALPA.

Lauren Jones left ALPA in December 2017 moving into a role with Nuffield Scholarships and we wished her well in her new position. Charlie Elliott started in January as administration manager replacing Lauren and is settling in well. Both Charlie and Sarrah Corner are a pleasure to work with in the Sydney office. They ensure ALPA events are well supported, professionally run and lots of fun for attendees. Lauren, Charlie, Sarrah, Andrea and Liz have assisted many members with all sorts of enquiries throughout the year with a friendly and helpful approach.

I look forward to continuing to lead and work with the ALPA team. It is rewarding to see just how far we have come as a national united body. We are ready for the future. The respect of ALPA amongst industry is second to none and we are there for the long haul, for the betterment of the livestock and property profession. It has been a pleasure serving my fourth year as Chairman of the Eastern Region Advisory Committee. I would like to thank ALPA CEO, Andy Madigan and ALPA staff for their support during this time.

Education

Continuing Professional Development (CPD) courses were run by ALPA all over the state and attendance has been increasing this year. The courses offered were ALPA Industry Awareness Days and Auctioneers Schools.

ALPA ran Industry Awareness Days in Armidale, Bathurst, Tamworth, Dubbo, Forbes, Griffith, Wagga Wagga and Sydney. These were attended by more than 210 members and the feedback was very pleasing. More of these are scheduled for this year, with up-to-date industry information and member services high on the agenda. NSW Fair Trading are making changes to CPD and our licences in 2018 and as we know more we will pass on to members. We understand there will be some compulsory units involved.

ALPA ran three Auctioneers Schools – Wagga Wagga (July 2017), Wagga Wagga (December 2017) which was the selection school for the NSW YAC and Tamworth (May 2018). I would like to thank the venues for allowing us the opportunity to run our schools there. I would like to also thank the trainers, Don Barbaro, Tom Boyle, Simon Burke, Peter Cox, Paul Jameson, Aaron Mackay, Dan O'Brien, Geoff Rice, Scott Simshauser, James Tierney and Joe Wilks for their invaluable guidance at these schools.

There was a strong field of participants vying for selection for the 2018 NSW YAC, at the December Wagga Wagga

school. Only ten competitors can be selected, but it's great to see there is still a lot of good, young auctioneering talent climbing the ranks.

I would like to personally thank the Sydney staff of ALPA and all who were involved in the organisation and running of these training courses. We are lucky to have such experienced people working with ALPA. Training and education is such an integral part of our industry and ALPA prides itself on providing a consistent dissemination of information to all members, nationally. We are proud of the results of our training and education programs, whether it be shaping young agents or keeping those involved in the industry up-to-date.

ALPA Young Auctioneers Competition

Over 320 competitors, members, industry representatives and other guests came to the ALPA Young Auctioneers Dinner this year, which was held for the ninth year in the city. The night was well received by all, with guests enjoying their night at Doltone House Hyde Park. A highlight was the charity auction conducted by 2017 ALPA National Young Auctioneers Competition Winner and International Livestock Auctioneer Rookie of the Year, Lincoln McKinlay and 2017 New Zealand Young Auctioneer Winner, Logan Moore, raising almost \$25,000 for Legacy Australia.

The competition, on Friday 23 March 2018, was another hard-fought battle, with 10 young auctioneers competing to be named 2018 ALPA NSW Young Auctioneer Winner. The winner this year was Tom Pollard of Elders, Dubbo, and the runner up was Baden Chaffey of Landmark Townsend, Scone. The ALPA

NSW Max Bailey Encouragement Award was presented to Jack Pippin of Spencer & Bennet – Yenda Prods, Griffith.

I would like to congratulate all the competitors from this year's competition and thank all the sponsors, officials and volunteers for the smooth running of the 2018 ALPA NSW and National Young Auctioneers Competitions.

ALPA Fairfax Media Agency Award

The Eastern Region had one finalist attend the national judging of the 2017 ALPA Fairfax Media Agency Award; Luke Kenniff, Harvest Agents & Advisory, Sydney.

The national judging was held the morning of the ALPA AGM in Adelaide. Simone Dand, Elders Adelaide, SA was awarded the 2017 ALPA Fairfax Media Agency Award for her nomination. I would like to congratulate Simone on this achievement.

Industry

During the next twelve months, once again, we will be faced with some serious challenges. I believe the two main issues will be animal welfare in saleyards and the imposing of Radio Frequency Identification (RFID) tags in the Victorian sheep industry.

Animal welfare in saleyards and during transport is coming under more and more scrutiny with major well-funded groups taking interest in the welfare of animals. We as industry must insure a zero tolerance to mishandling of livestock. The live export livestock business has seen the evidence of what a media campaign can have on commodity prices where mistreatment of livestock was suggested.

ALPA have recently reviewed the NSW Complaints Register Guidelines, which will include information such as the name of business and its location, the number of complaints received and the product or service complained

about. ALPA provided its recommendations to the NSW Commissioner for Fair Trading on the proposed complaints register.

Minister Niall Blair invited Andy Madigan to meet with him in June about the drought and the affects it is having on NSW rural communities. He told Andy that he wanted to pass on his gratitude to agents and their staff around the state who have been doing a wonderful job helping farmers handle the drought, their livestock and their mental wellbeing. He also knows the physical and mental impact it has on all staff at an agency business and in a community.

I would like to thank my fellow NSW committee Peter Cabot, David Corcoran, Peter Cox, Geoff Rice, Luke Scicluna and Michael Wright for their assistance over the past twelve months. Their time and valuable contributions assist ALPA in achieving positive results within the rural sector.

In NSW we are very lucky to have a great mix of youth and experience in which I have been able to call on at any given time for advice and help.



NORTHERN REGION ADVISORY COMMITTEE REPORT

The past twelve months has seen parts of the state with half decent seasonal conditions while other areas are still in dire need of rainfall. At the beginning of June 58% of Queensland was still drought declared. Some of these regions have been in this situation for far too long. We can only pray that general widespread rains come sooner rather than later to help these areas on what will be a long journey to recovery.

The cattle market remained firm for the best part of 2017–18 with values only dropping in the last couple of months. The dry conditions covering vast areas in Queensland, NSW and Victoria have forced large numbers onto the market creating a reduction in prices across the board. Once again, rainfall is the answer.

This is my sixth year serving on the Northern Regional Advisory Committee and it has been pleasing in that time to see ALPA strengthening its position as our industry's leading body. I would like to thank my fellow committee members Cyril Close, Peter Daniel, Colby Ede, Paul Holm and Stephanie Whitaker for their commitment, time and support for our organisation.

Fducation

The future of the agency industry seems to be in good hands if the 28 participants of the two-day auctioneers school held in Gracemere, 11-12 June are any indication. Only a few faces were familiar with the majority of the group being first time attendees. Note 1 - Summary of Significant Accounting Policies

A) Basis of Preparation

The financial statements are general purpose financial statements that have been prepared in accordance with Australian Accounting Standards - Reduced Disclosure Requirements of the Australian Accounting Standards Board and the Corporations Act 2001.

Australian Accounting Standards set out accounting policies that the AASB has concluded would result in financial statements containing relevant and reliable information about transactions, events and conditions. B) Impairment of Assets

Assets that are subject to depreciation are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs to sell and value in use.

C) Depreciation

Depreciation is calculated on the straight line basis so as to write off the net cost of each fixed asset during its expected useful life. Profit and losses on disposal of fixed assets are taken into account when determining profit and loss.

The depreciation rates used for each class of depreciable assets are:

Buildings 2% Office Equipment 15%

The asset's residual values and useful lives are reviewed, and adjusted if appropriate, at each reporting period.

D) Employee Benefits

Provision is made for the company's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Consideration is given to the employee wage increases and the probability that the employee will not meet its vesting requirements.

Contributions are made by the entity to an employee superannuation fund and are charged as expenses when incurred.


